- Barnett, Robert, and Jacob Blumner. *The Longman Guide to Writing Center Theory and Practice*. New York: Cambridge UP, 2007. Print.

This book anthologizes essays on all major areas of interest to writing center theorists and practitioners. Seven sections provide a comprehensive view of writing centers: history, progress, theorizing the writing center, defining the writing center's place writing-across-the curriculum, the practice of tutoring, cultural issues, and technology.

Each series volume contains engaging essays from different writing teachers in the field and explores important topics about writing in a manner and style accessible both to teachers and students. While the first volumes focus on instructional texts for first-year composition, future editions may feature texts for writing in the disciplines and professional writing classrooms.

Rafoth, Ben. Multilingual Writers and Writing Centers. Logan: Utah UP, 2015. Print.

This book addresses the needs of multilingual writers in the writing center. It draws on writing center practice and second language acquisition research to provide writing center directors and tutors with knowledge and practices that help them negotiate the complexities of multilingual and multicultural communication.

Ritter, Kelly, and Paul Kei Matsuda, eds. *Exploring Composition Studies: Sites, Issues, and Perspectives*. Logan: Utah State University Press, 2012.

Students will find this collection useful because it provides a good overview of the various areas of research and pedagogy in rhetoric and composition. This includes, but is not limited to: computers and writing, history, archival and ethnographic research, WPA and WAC program development, and the relationship between rhet-comp and professional writing as well as TESL. These articles also provide a good history of how the field defines various key terms from the perspective of major scholars. Massey, Lance, and Richard C. > Students will find this collection useful because it provides an overview of the major methods and methodologies in rhetoric and composition research. This is done through articles both that describe methodologies and their theories/histories, as well as through examples of particular methodological approaches in action (archival, ethnographic, bibliometric, etc). This text also discusses a landmark book on method in the field—Stephen North's The Making of Knowledge in Composition—and will provide students a sense of the field's history of methodological questions and issues.
